VUWANI SOCIAL COHESION COMMUNITY CONVERSATIONS DEPARTMENT OF ARTS AND CULTURE

Introduction and Background

- The Demarcation Board issued a declaration on a new municipality
- The new municipality incorporates Malamulele area and Vuwani
- Malamulele experienced violent service delivery protests demanding to opt out of the Thulamela Municipalty (head-quartered in Thohoyandou) to have own municipality
- There is a suggestion by people in the area the new municipality is a compromise by the Demarcation Board to appease Malamulele
- Vuwani community is refusing to be incorporated into the new municipality and wants the status quo to remain i.e. remain part of Makhado Local Municipality
- Traditional leaders in the area have also joined in and are sympathetic to the cause
- There is an Inter-Ministerial Committee (IMC) appointed by the President to assist in the mediation effort and bring the matter to normality
- The IMC is supported by a Technical IMC (which the DAC)
- The area is facing unrest schools burnt, furniture destroyed
- Out of the 102 schools in the area, there is no schooling in over 70 of the schools
- Level of intimidation on the teachers and principals very high
- The DAC has a mandate in terms of coordination of outcome 14 (social cohesion and nation building)
- The Minister directed the Department to initiate community conversations in the area as a way to bridge the divisions

The Methodological Approach

- Methodologically speaking, the community conversations will take a more critical and phenomenological posture
- Conversations will be cognisant of the fact that oppressive structures are a lived daily reality for the majority of our people
- The conversations will interrogate and mediate these constraining elements
- Levers for social cohesion are located from within the communities [not so much solutions from without]
- However, the conversations provide a dialogic platforms leading to finding of these levers (opportunities for cohesion)
- Employ the "sustain dialogue" method continuing with the dialogue assisting tools and leveraging on existing structures and resources to sustain the dialogue
- "Sustain dialogue" entails a process for improving relationships within communities that may largely be strained along, among others, racial, ethnic, gender, class, religious, and cultural lines
